Regular Session Meeting

Chair Silvia Nerssessian opened the meeting at 7:03 p.m.

- 1. Opening Statement / Regular Session
 - a. - 3. Educational Matters
 - a. District Reports
 - i. Director of Business and Human Resources Report
 - Director of Business and Human Resources Don Sawyer shared with the Committee that Governor Baker signed the state budget and with that we were notified that there was an increase to Chapter 70 funds, the state is continuing to provide universal free lunch for all students and that the Business Department would be communicating that with families.
