# Sudbury School Committee Meeting Minutes June 16, 2025

#### 1. Open Executive Session

### Business and Policy Matters

- a. Review Results from School Committee Communications Survey
  - i. The survey received 163 responses. Results included half of the respondents had not previously communicated with the School Committee though 68% watched a meeting. Half of the respondents found the survey useful and a large number of respondents had a preference for receiving information through a newsletter. Future considerations include a quarterly newsletter, timing of surveys and minor adjustments to survey questions.

### b. Draft 2025-2026 Superintendent Goals

- Superintendent Crozier reviewed his Student Achievement, District Improvement, and Professional Practice goals, outlining the action steps and evidence of success for each. He also presented related indicators of practice.
- ii. The Committee asked questions about each of his proposed goals, including how they address community engagement and measurable outcomes. They asked whether his newly appointed national leadership role would be incorporated into his Professional Practice Goal. Related to the District Improvement Goal, they asked if relevant data would be accessible to parents. Additional clarifying questions focused on MTSS and UDL, how staff training data would be measured, and any planned measures for incoming 8th graders related to math.

#### c. 2025-2026 School Committee Goals

### d. Gender Identity Policy

- i. Chair Karyn Jones reviewed the packet materials with the Committee, aiming to determine whether to move forward with the proposed policy. The process to create a new policy includes an initial review, member input and a final vote. The recommendation is to adopt DESE's policy with edits and refer it to counsel.
- ii. Questions related to the timing of legal review and staff input were asked.

    - 1. The Committee engaged in discussion about concerns that the policy had not been written with the full Committee during open session.
    - 2. Clarifying questions focused on who drafted the policy, the processes used for policy development, and what additional policies from previous Policy Subcommittee meetings may be presented for review.
    - 3. The Committee agreed to discuss these policies at the next School Committee meeting.
    - 4. Mandy Sim rescinded her motion to postpone the discussion.
- f. Calendar Review Sub Committee / Tri-District Calendar Review Sub Committee
  - i. Chair Karyn Jones shared that due to the potential concerns about an open policy violation during a recent meeting, MASC recommended a motion to combine the three subcommittees into a single Tri-District Calendar Review Subcommittee. Both Lincoln and LSRHS have already moved forward with this vote.
  - ii. Questions from the Committee related to council input.
    - Chair Karyn Jones moves to combine the 3 existing Calendar Review Subcommittees, Sudbury Public Schools, Lincoln Public Schools and Lincoln Sudbury Regional High School into a single Tri-District Calendar Review Subcommittee composed of representatives from each of the three districts.
