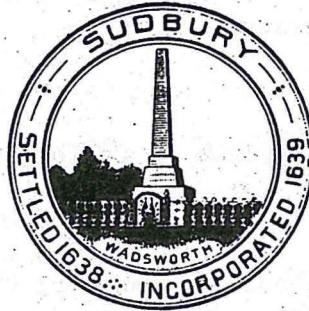

TOWN OF SUDBURY
SPECIAL TOWN MEETING WARRANT
COMMONWEALTH OF MASSACHUSETTS

Middlesex, ss.

To the Constables of the Town of Sudbury:

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Sudbury, qualified to vote in Town affairs, to meet at the Lincoln-Sudbury Regional High School Auditorium in said Town on Monday, October 3, 1988, at half past seven o'clock in the evening, then and there to act on the following articles:

ARTICLE 1 ACCEPT M.G.L. C.59 §5, CLAUSE FIFTH B - TAX EXEMPTION
FOR VETERANS' ORGANIZATIONS

To see if the Town will vote to accept M.G.L. Chapter 59, Section 5, Clause Fifth B, established by Chapter 499 of the Acts of 1987, regulating real estate and personal property tax exemptions of organizations for veterans of war; or act on anything relative thereto.

Submitted by the Board of Selectmen and Board of Assessors.

Printed below is General Laws Chapter 59, §5, Clause Fifth B:

"The following property shall be exempt from taxation and the date of determination as to age, ownership or other qualifying factors required by any clause shall be July first of each year unless another meaning is clearly apparent from the context;...

Fifth B, The real and personal estate belonging to or held in trust for the benefit of incorporated organizations of veterans of any war in which the United States has been engaged, to the extent of seven hundred thousand dollars, if used and occupied by such association, and if the net income from said property is used for charitable purposes; provided, however, that such estate shall not be exempt for any year in which such association or the trustees holding for the benefit of such association wilfully omit to file with the assessors the list and statement required by section twenty-nine. This clause shall take effect upon its acceptance by any city or town. In a city or town which accepts the provisions of this clause, the provisions of clause Fifth and Fifth A shall not be applicable."

BOARD OF SELECTMEN AND BOARD OF ASSESSORS REPORT: Acceptance of Clause Fifth B by the Town will exempt the local Veterans' American Legion Post 191 on Boston Post Road from real estate and personal property taxes up to a value of \$700,000. Currently, they are exempted from paying taxes on a value up to \$200,000 under the provisions of Clause Fifth, which reads as follows:

"The following property shall be exempt from taxation and the date of determination as to age, ownership or other qualifying factors required by any clause shall be July first of each year unless another meaning is clearly apparent from the context;...

Fifth, The real and personal estate belonging to or held in trust for the benefit of incorporated organizations of veterans of any war in which the United States has been engaged, to the extent of two hundred thousand dollars, if actually used and occupied by such association, and if the net income from said property is used for charitable purposes; but it shall not be exempt for any year in which such association or the trustees holding for the benefit of such association wilfully omit to bring in to the assessors the list and statement required by section twenty-nine."

We recommend approval.

ARTICLE 2 TRANSFER LAND TO SELECTMEN FOR SALE
TO SUDBURY WATER DISTRICT

- A. To see if the Town will vote to transfer from the control of the Sudbury School Committee to the Selectmen for the purpose of sale to the Sudbury Water District of Sudbury the following described land:

A portion of the land adjacent to the Curtis Middle School shown on Town Property Map H07, Parcel 027, containing approximately 19.6 acres, and more particularly described as Parcel A on a plan entitled, "PLAN OF LAND IN SUDBURY, MASSACHUSETTS SHOWING LAND TO BE CONVEYED TO THE SUDBURY WATER DISTRICT", dated August 29, 1988, drawn by the Town of Sudbury Engineering Department;

and

- B. To see if the Town will vote to transfer from the control of the Selectmen to the Selectmen for the purpose of sale to the Sudbury Water District of Sudbury the following described land:

Parcel 239 located off Blueberry Hill Lane and shown on Town Property Map H07, containing approximately 1.6 acres, and more particularly described as Lot 39 on a plan entitled, "PLAN OF LAND IN SUDBURY, MASSACHUSETTS SHOWING LAND TO BE CONVEYED TO THE SUDBURY WATER DISTRICT", dated August 29, 1988, drawn by the Town of Sudbury Engineering Department;

or act on anything relative thereto.

Submitted by the Board of Selectmen.

(Two-thirds vote required.)

BOARD OF SELECTMEN REPORT: The purpose of this and the next Article is to transfer Town property to the Water District to enlarge the protection district for new and proposed wells in the upper Hop Brook area. This area is vital to the drinking water supply in the event that an accident should happen to our prime area, the Raymond Road well fields. The Board recommends approval.

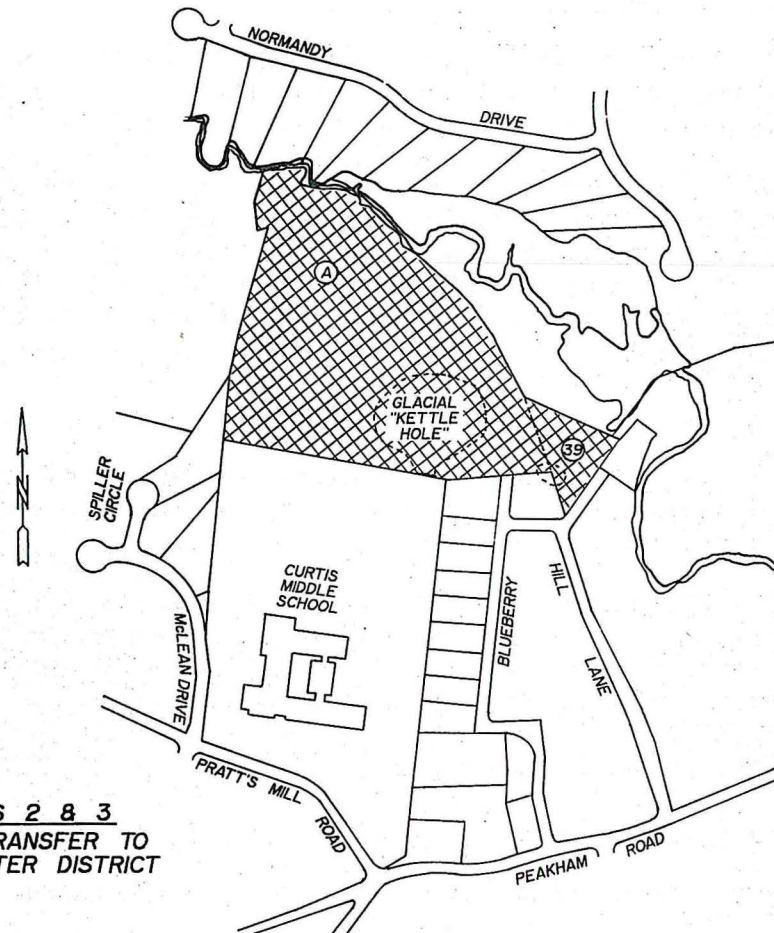
ARTICLE 3 DEED LAND TO WATER DISTRICT

To see if the Town will vote to authorize the Board of Selectmen, acting on behalf of the inhabitants of the Town of Sudbury, to execute a deed or deeds conveying to the Sudbury Water District of Sudbury the following described land: a portion of the land adjacent to the Curtis Middle School, consisting of a portion of Parcel 027 as shown on Town Property Map H07 and more particularly described as Parcel A on a plan entitled "PLAN OF LAND IN SUDBURY, MASSACHUSETTS SHOWING LAND TO BE CONVEYED TO THE SUDBURY WATER DISTRICT", dated August 29, 1988, drawn by the Town of Sudbury Engineering Department, and containing 19.6± acres according to said plan; and Parcel 239 as shown on Town Property Map H07 and more particularly described as Lot 39 on the above entitled plan, and containing 1.6± acres according to said plan; and to determine the minimum compensation to be paid therefor; or act on anything relative thereto.

Submitted by the Board of Selectmen.

(Two-thirds vote required.)

LAND TRANSFER TO
THE WATER DISTRICT**

ARTICLE 4 AMEND BYLAWS, ART. V, 10, PUBLIC SAFETY - CORRECTION

To see if the Town will vote to amend Article V of the Town of Sudbury Bylaws, Public Safety, by deleting therefrom Section 10 in its entirety and substituting therefor a new Section 10 to read as follows:

"No person, unless authorized by law or by appropriate authority as evidenced by a sticker or permit, shall deposit garbage, waste, vegetable matter, or any trash, refuse, rubbish or other permitted waste material in any disposal area or sanitary landfill maintained by the Town. Violation of this section shall be subject to a penalty of \$50. Each day during which a violation exists shall be deemed to be a separate violation.";

or act on anything relative thereto.

BOARD OF SELECTMEN REPORT: The existing Section 10 contains only the penalty provision (the second and third sentence above). The subject of the Section (the first sentence of the amendment above) was inadvertently deleted when amendments were made under Article 43 of the 1988 Annual Town Meeting. We urge approval of this technical correction.

ARTICLE 5 AMEND SPECIAL PERMIT BYLAWS TO CONFORM TO M.G.L. CHAPTER 40A

To see if the Town will vote to amend Article IX of the Town of Sudbury Bylaws, the Zoning Bylaw, by making the following changes thereto:

- deleting subparagraph f, Paragraph 6, Subsection G, Section III, Procedures for Issuance of Special Permit, Water Resource Protection Districts and relettering paragraph g as "f";
- deleting paragraph 7, Public Hearing and Decision, and paragraph 13, Effective Date of Special Permit, of Subsection D, Section IV, Cluster Development, and renumbering the remaining paragraphs accordingly;
- deleting paragraph 7, Public Hearing and Decision, and paragraph 13, Effective Date of Special Permit, of Subsection A, Section V, Site Plan Special Permit, and renumbering the remaining paragraphs accordingly;
- deleting paragraph 3, Procedures, and paragraph 4, Appeals, of Subsection C, Section VI, Board of Appeals, and renumbering the remaining paragraphs accordingly;

or act on anything relative thereto.

(Two-thirds vote required.)

BOARD OF SELECTMEN REPORT: This Article deletes those provisions of the Zoning Bylaw dealing with procedure for hearing of and decision on applications for variances and special permits. The procedural requirements are dictated by Chapter 40A of the General Laws, The Zoning Act. The procedural requirements have been amended several times recently. Each amendment of Chapter 40A necessitates a corresponding amendment of the Zoning Bylaw. As now worded, the

Bylaw is not in compliance with the current requirements of Chapter 40A. This Article is intended to eliminate the need of continually amending the Bylaw to conform to The Zoning Act. Since the procedural requirements are mandated by Chapter 40A, it is not necessary that they be repeated in the Bylaw. The Board of Selectmen recommends approval of this Article.

ARTICLE 6 AMEND ZONING BYLAW, ART. IX, VI, D, ADMINISTRATION - PENALTY

To see if the Town will vote to amend Section VI, "Administration", of Article IX of the Town of Sudbury Bylaws, the Zoning Bylaw, by deleting therefrom subsection D and substituting therefor the following:

"D. PENALTY

Violation of any provision of this bylaw, not otherwise provided for herein, shall be subject to a penalty of \$50. Each day during which a violation exists shall be deemed to be a separate violation.";

or act on anything relative thereto.

(Two-thirds vote required.)

BOARD OF SELECTMEN REPORT: Article IX of the Bylaws sets forth all the zoning regulations for the Town of Sudbury. Section VI of Article IX governs the administration of zoning matters and sets forth in subsection D a penalty for violations. The only change proposed in this warrant article is to amend the penalty in Subsection D from a range of 0 to \$100 to a specific penalty of \$50 so that zoning violations can be prosecuted as non-criminal matters instead of criminal proceedings as we must do under the current Bylaw. The ability to impose a civil penalty rather than engage in costly and time-consuming criminal proceedings will speed correction of zoning violations. This proposed Zoning Bylaw amendment was defeated at the 1988 Annual Town Meeting under Article 46 only because of a failure to make clear to the voters the intent and effect of the Article. Similar amendments to other sections of the Bylaws WERE approved at the 1988 Annual Town Meeting; this amendment which was omitted is most important because it deals with zoning violations which comprise the most prevalent citizen complaints. We urge your approval.

Printed below is subsection D, as it currently exists:

"D. PENALTY

Any person violating any provision of this bylaw shall be subject to a fine not exceeding \$100.00 for each violation. Each day during which any violation exists shall be deemed a separate offense."

ARTICLE 7 CHANGE APPOINTING AUTHORITY FROM MODERATOR TO SELECTMEN -
ANCIENT DOCUMENTS COMMITTEE AND PERMANENT BUILDING COMMITTEE

To see if the Town will vote to:

- A. Change the method of appointment of members of the Permanent Building Committee to provide that the two members currently appointed by the Moderator shall hereafter be appointed by the Board of Selectmen; and

- B. Change the method of appointment of members of the Committee for the Preservation of Ancient Documents to provide that the six members currently appointed by the Moderator shall hereafter be appointed by the Board of Selectmen;

or act on anything relative thereto.

Submitted by the Board of Selectmen on behalf of the Town Moderator.

BOARD OF SELECTMEN REPORT: The Town Moderator believes there is no basis for singling out members of the above two committees for appointment by the Moderator. He believes the Selectmen's Office receives more information as to persons who might be interested in serving in these positions and the Board of Selectmen is cognizant of the needs of these committees and could more easily handle the same when making its other annual appointments.

The Committee for the Preservation of Ancient Documents was established as a permanent committee by Town Meeting in 1964 and is comprised of seven members - the Town Clerk and six appointees of the Moderator. Its duties are to investigate the condition of all ancient records, both public and private, as may be in the custody of the Town and to develop procedures for acquisition and preservation of such documents as it may deem to be of historical importance.

The Permanent Building Committee was established in 1957 by Town Meeting, with later amendments, and is made up of seven members appointed as follows: 2 by the Moderator, 3 by the Selectmen, 1 by the Planning Board, and 1 by the School Committee. The duty of this Committee is to have general supervision over the design and construction of all public buildings, including the authority to employ professional assistance and, subject to specific authorization by the Town, to enter into contracts on behalf of the Town for the preparation of construction plans and specifications and for the construction of buildings and other structures; all subject to approval of the appropriate committee, board, or department head concerned.

If the Town desires, the Board of Selectmen is willing to assume the specified appointive duties and supports this Article.

FINANCE COMMITTEE REPORT: Recommend approval.

ARTICLE 8

SPECIAL ACT AND APPROPRIATION
REAL ESTATE TAX ABATEMENT FOR E. SIMON

- A. To see if the Town will vote to approve the petition set forth herein providing for the payment of a real estate tax abatement to Estelle Vee Simon and request the Board of Selectmen to petition the General Court of the Commonwealth of Massachusetts to enact the special legislation set forth in said petition and without further submission to a Town Meeting:

"The Commonwealth of Massachusetts

In the year one thousand nine hundred and eighty-eight.

An Act authorizing the Town of Sudbury to pay Estelle Vee Simon a real estate tax abatement for the years 1981 through 1987.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by authority of the same, as follows:

Section 1. Notwithstanding the provisions of Chapter 59 of the General Laws, the Town of Sudbury is authorized to pay Estelle Vee Simon \$504.70 for an abatement to her real estate taxes paid on her property at 27 Surrey Lane, Sudbury, for the years 1981 through 1987, on account of a correction of the record of the date the dwelling thereon was built.

Section 2. This Act shall take effect upon its passage.";

and

B. To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$505 to pay Estelle Vee Simon a real estate tax abatement, provided such action is approved by the General Court by passage of the Special Act set forth in part A above;

or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: This Article was submitted on behalf of Estelle Simon to avoid any burden on herself to do so. The Board supports this Article.

ARTICLE 9 AMEND BYLAW, ART. V(C), I - SMOKING PROHIBITION, PENALTY

To see if the Town will vote to amend Article V(C), Smoking Prohibition, by deleting therefrom section (i) in its entirety and substituting therefor the following:

"(i) Any person who knowingly violates any provision of this article, or who smokes in an area in which a "Smoking Prohibited by Law" notice is conspicuously posted as required by subsection (g) of this article, shall be subject to a penalty of \$25.00. Each day during which a violation exists shall be deemed to be a separate violation.";

or act on anything relative thereto.

Submitted by the Board of Health.

BOARD OF HEALTH REPORT: The only change proposed in this warrant article is to amend the penalty from a range of \$25 to \$100 to a specific penalty of \$25 so that violations can, if desired, be prosecuted as non-criminal matters instead of criminal proceedings which is the only process available for enforcement under the current bylaw.

Printed below is section (i), as it currently exists:

"(i) Any person who knowingly violates any provision of this article, or who smokes in an area in which a "Smoking Prohibited by Law" notice is conspicuously posted as required by subsection (g) of this article, shall be fined in an amount of not less than twenty-five (\$25.00) nor more than one hundred (\$100.00) dollars."

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 10 ACCEPT M.G.L. c.59 §21A½, PROFESSIONAL DESIGNATION COMPENSATION
- ASSESSORS & ASSISTANT ASSESSORS

To see if the Town will vote to accept the provisions of Massachusetts General Laws Chapter 59, Section 21A½, which provides for additional compensation in an amount equal to ten percent of such regular compensation (salary) for Assessors and Assistant Assessors who have been awarded a certificate by the International Association of Assessing Officers as certified assessment evaluators or awarded a certificate by the Association of Massachusetts Assessors as certified Massachusetts Assessors; or act on anything relative thereto.

Submitted by the Board of Assessors.

ASSESSORS' REPORT: Acceptance of this law will provide the encouragement and the recognition for the position of Assistant Assessor to work toward and obtain these designations and as a result serve as a greater asset to the Town as well as provide an attraction for qualified and professional Assessors in the future.

Printed below is Section 21A½ of G.L. Chapter 59:

"In any city or town which accepts this section, an assessor or assistant assessor, who has completed the necessary courses of study and training and has been awarded a certificate by the International Association of Assessing Officers as a certified assessment evaluator or who has been awarded a certificate by the Association of Massachusetts Assessors as a certified Massachusetts assessor, shall receive as compensation from such city or town, in addition to the regular compensation paid by such city or town for services in such office, an amount equal to ten per cent of such regular compensation. An assessor who has been awarded both certificates referred to above shall receive such additional compensation for only one of such certificates. In order to qualify for such additional compensation, an assessor or assistant assessor shall submit proof that he has been awarded either or both of the aforesaid certificates to the mayor or the board of selectmen of such city or town. The additional compensation herein provided shall be prorated for any twelve month period in which an eligible person does not hold the office of assessor or assistant assessor for twelve consecutive months. In those cities and towns which accept the provisions of section twenty one A, this section shall not be applicable."

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 11 UNPAID BILLS

To see if the Town will vote to raise and appropriate, or appropriate from available funds, a sum of money for the payment of the following unpaid bill(s), incurred in previous fiscal years, or which may be legally unenforceable due to the insufficiency of appropriation in the years in which such bills were incurred, totalling \$5,100:

\$ 5,099.17 to pay Bursaw Gas & Oil, Inc. for diesel fuel taxes from prior years;

or act on anything relative thereto.

Submitted by the Town Accountant.

(Majority vote required.)

TOWN ACCOUNTANT REPORT: Invoices that are submitted for payment after the accounts are closed at the end of a fiscal year or payables for which there are insufficient funds (and which were not submitted for a Reserve Fund transfer) can only be paid by a vote of the Town Meeting, a Special Act of the Legislature, or a court judgement. During the period January 1, 1985 through June 30, 1988 the Town's supplier of diesel fuel for motor vehicles failed to charge the Town the special fuels tax as required by M.G.L. c.64E and for which the Town, having used such fuel, is liable under said c.64E. The omission was discovered during a recent audit by the Department of Revenue.

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 12 AMEND BYLAW, ARTICLE XI - SALARY PLAN GRID

To see if the Town will vote to amend Article XI of the Town of Sudbury Bylaws entitled, "The Personnel Administration Plan", by deleting therefrom the salary grid portion of Schedule B - Salary Plan, and substituting therefor the following salary grid:

PERSONNEL BOARD REPORT: The salary grid for non-union employees has been adjusted for symmetry, in order to avoid artificially higher increases as a result of reclassification. The new grid shows slight increases in starting salaries, only \$1-2 increases in maximum annual salaries, and will save the Town money when an employee is moved from one grade (classification) to another. The grid shown is based on FY1988 salaries to provide a clear picture of the limited scope of the Article.

ARTICLE 13 AMEND BYLAW, ARTICLE IV, FINANCE COMMITTEE -
ARTICLE CONSIDERATION

To see if the Town will vote to amend the Town of Sudbury Bylaws, Article IV, Finance Committee, Section 4, by deleting the first sentence therefrom and substituting the following:

"It shall be the duty of this committee to consider all articles of any Town Meeting Warrant which have any direct or indirect financial impact on the Town and to report its recommendations in writing to the Board of Selectmen. The committee may also make recommendations on those articles which do not have financial impact on the Town as it chooses, and such recommendations shall likewise be reported to the Board of Selectmen.";

or act on anything relative thereto.

FINANCE COMMITTEE REPORT: The current Town Bylaws require the Finance Committee to report at Town Meetings on every article. The Finance Committee is requesting that this Bylaw be changed so that the requirement does not extend to those articles which have no apparent financial impact to the Town. There is a considerable amount of time expended on such articles which could be better spent in dealing with the Finance Committee's principal responsibilities. Articles which, in the opinion of the Committee, could have a direct or indirect financial impact on the Town will still be reported on at Town Meeting with a corresponding recommendation for approval or disapproval. The Finance Committee recommends approval of this article.

Printed below is the full text of Section 4 as it currently stands:

"It shall be the duty of this committee to consider all articles of any Town Meeting Warrant, and report in writing to the Selectmen, their recommendations. The Selectmen shall cause the report for the annual meeting to be printed in the Town Report and the Finance Committee's reasons for approval or disapproval printed directly beneath the article considered in the Town Warrant."

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 14 SPECIAL ACT - POLICE TEMPORARY

To see if the Town will vote to approve the petition set forth herein providing for the certification with residency status of a Police Officer for appointment to the Sudbury Police Department and request the Board of Selectmen to petition the General Court of the Commonwealth of Massachusetts to enact the special legislation set forth in said petition:

"The Commonwealth of Massachusetts

In the year one thousand nine hundred and eighty-eight.

An Act authorizing and directing the Personnel Administrator of the Commonwealth of Massachusetts to certify Todd F. Eadie for appointment as a Police Officer in the Town of Sudbury.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by authority of the same, as follows:

Section 1. Notwithstanding the provisions of Chapter Thirty-one of the General Laws or any other law, rule or regulation to the contrary, the Personnel Administrator of the Commonwealth of Massachusetts is hereby authorized and directed to certify the name of Todd F. Eadie for appointment as a police officer in the Town of Sudbury Police Department, according to his score on the most recent examination therefor, as though he had resided in said Town of Sudbury for one year immediately prior to the date of such examination.

Section 2. This Act shall take effect upon its passage.";

or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: The purpose of this special legislation is to ultimately make a temporary patrolman position in the Police Department a permanent one. The incumbent in the position, Officer Todd Eadie, had to be appointed as a Temporary Patrolman to protect the State Civil Service rights of the current Chief of Police at the time of his appointment. Because Officer Eadie has since moved from Sudbury, this legislation is required to place Officer Eadie's name in a position on the list which will allow the Board of Selectmen to appoint Officer Eadie as a Permanent Patrolman. It should be noted that Officer Eadie's examination score would have placed him at the top of the certified residential list. We are working with Senator Cellucci, Representative Hicks, the House and Senate, and the Division of Personnel Administration to bring this matter to an amicable resolution. The Board will make further report at Town Meeting.

ARTICLE 15 FY89 BUDGET ADJUSTMENT - 350TH CELEBRATION

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$15,000, or any other sum, for Line Item 715-210, 350th Celebration General Expense, as an addition to the Fiscal Year 1989 Budget voted by the 1988 Annual Town Meeting under Article 5; or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: These funds are again being requested on behalf of the Sudbury 350th Anniversary Celebration Committee in order that up-front monies might be available to hire marching bands for the September 4, 1989 parade. To date we are unable to find private sponsors. It is our belief that such a 350th celebration parade will not be as successful without marching bands; therefore, it is our intent to have at least three major marching bands and several smaller units. The money raised privately to date is nearly

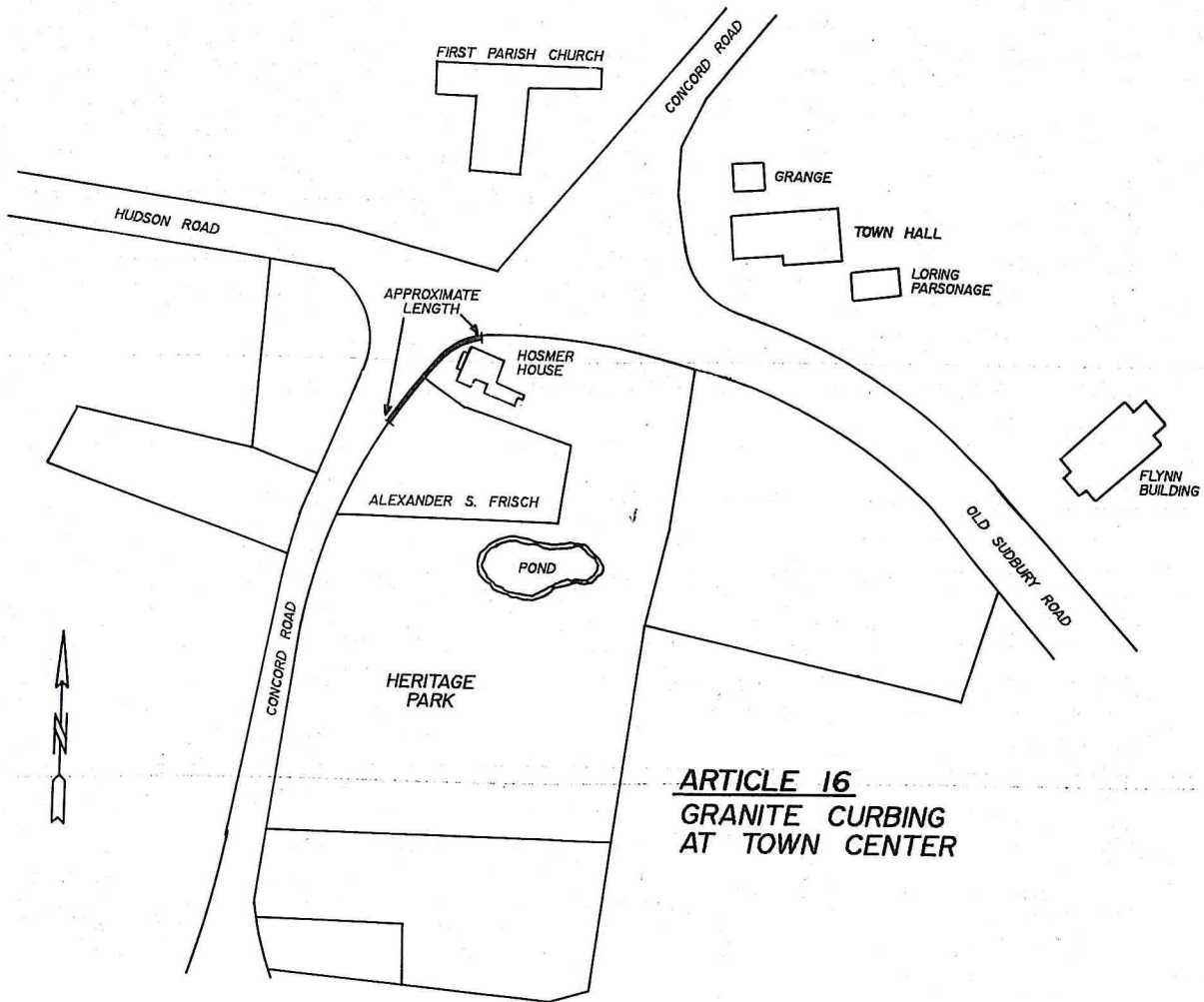
\$20,000 and this is needed to cover up-front costs for the September 2, 1989 Ball and September 3, 1989 picnic and laser show. It is expected that the 350th celebration proceeds will be substantial and these monies will be donated back to the Town. For example, the Bicentennial dance proceeds in excess of \$10,000 were donated to the Town for use at the Hosmer House. We urge your support of this Article.

FINANCE COMMITTEE REPORT: Recommend disapproval.

ARTICLE 16 GRANITE CURBING - CONCORD ROAD AT TOWN CENTER

To see if the Town will vote to raise and appropriate, or appropriate from available fund, \$8,500, or any other sum, to be expended under the direction of the Highway Surveyor, for the purpose of installing granite curbing along the easterly side of Concord Road from Heritage Park northerly to Old Sudbury Road for a distance of approximately 325 feet, as shown on a plan entitled "Proposed Alterations at Heritage Park/Hosmer House", prepared by the Town of Sudbury Engineering Department, dated July 14, 1987, revised August 4, 1988; or act on anything relative thereto.

Submitted by the Board of Selectmen.



BOARD OF SELECTMEN REPORT: The purpose of this Article is to correct an emergency situation that exists at the intersection of Old Sudbury and Concord Roads. The amount of funds requested herein will be used to provide permanent curbing to avoid flooding of the Hosmer House and avoid wash outs at this major intersection. The Board recommends approval of this Article.

ARTICLE 17 WALKWAY SUPPLEMENT - GOODMAN'S HILL & PEAKHAM ROADS

To see what sum the Town will vote to raise and appropriate, or appropriate from available funds, to be expended under the direction of the Highway Surveyor, for the construction of walkways along the following roads:

- A) Goodman's Hill Road from Concord Road to Nashoba Road; and
- B) Peakham Road from Fox Run Road to the railroad tracks;

or act on anything relative thereto.

Submitted by the Planning Board.

PLANNING BOARD REPORT: The Long Range Walkway Development Program, initiated as a result of Town Meeting action at the 1984 Annual Town Meeting, continues to add new walkways. The purpose of this Article is to provide additional construction funds for the Goodman's Hill and Peakham Road walkways, as actual construction costs have exceeded previously appropriated construction funds. The 1986 Annual Town Meeting authorized funds for construction of a walkway along Peakham Road from Fox Run to the railroad tracks. The 1987 and 1988 Annual Town Meetings authorized funds for construction of a walkway along Goodman's Hill Road from Concord Road to Nashoba Road. Final engineering of the Peakham Road walkway and Goodman's Hill Road walkway was completed in 1988. Construction of the Peakham Road walkway and Goodman's Hill Road walkway has been scheduled during the fall of 1988.

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 18 CONSULTANT TO DELINEATE AQUIFER ZONES I, II, & III
IN PANTRY BROOK WATERSHED

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$10,000, or any other sum, to be expended under the direction of the Board of Selectmen, to hire a consultant to identify and delineate aquifers (Zone I), aquifer contribution zones (Zone II) and aquifer recharge zones (Zone III) in the Pantry Brook Watershed for inclusion within Water Resource Protection Districts under the Zoning Bylaw; or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: Funds are requested to be used in conjunction with the Water District to hire a consultant to determine the location of well site(s) (Aquifer Zone I) in the Pantry Brook area and, further, to delineate related Aquifer Zones II and III. The results will be used to include these

areas under the protection of the Zoning Bylaw, Water Resource Protection Districts, established under Article 64 of the 1988 Annual Town Meeting. The Pantry Brook Watershed comprises over 3,000 acres north of Sudbury Center, centering around the Pantry Brook complex of streams which empty into the Sudbury River. The Board of Selectmen supports this Article.

ARTICLE 19 CONSULTANT TO STUDY AQUIFER ZONES II & III

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$10,000, or any other sum, to be expended under the direction of the Board of Selectmen, to hire a consultant to review the identification and designation of aquifer contribution zones (Zone II) and aquifer recharge zones (Zone III) within Water Resource Protection Districts established by the 1988 Annual Town Meeting amendments to the Zoning Bylaw under Article 64; or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: The purpose of this Article is to hire a consultant to verify, expand, or contract Zones II and III of the Town's new Water Resource Protection Districts. As was witnessed at the 1988 Annual Town Meeting, there was a difference of opinion as to the accuracy of the boundaries of Zones II and III. Professional opinions and existing data warrant that we bring this issue back to Town Meeting for funds to refine the Zones in order to avoid future legal challenges. The Board recommends approval of this Article.

ARTICLE 20 POLICE PAID DETAIL ACCOUNT

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$5,000, or any other sum, to be added to the Police Paid Detail Account; or act on anything relative thereto.

Submitted by the Town Accountant.

TOWN ACCOUNTANT REPORT: It has been the practice for the Town to pay police officers for private paid detail work immediately, as worked. The outside party for whom the detail was worked then reimburses the Town. Due to untimely reimbursements, a running deficit has occurred in this account which must be funded to keep payments current and to balance the account at year end. The Police Chief and the Board of Selectmen support this article.

ARTICLE 21 FY89 BUDGET ADJUSTMENT - EDUCATION, MRVTS

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$79,922, or any other sum, as an addition to Sudbury's Fiscal Year 1989 assessment for the Minuteman Regional Vocational Technical High School, line item 100-140, voted by the 1988 Annual Town Meeting under Article 5, Budget; or act on anything relative thereto.

Submitted by Minuteman Regional Vocational Technical School District.

MRVTS SUDBURY REPRESENTATIVE'S REPORT: An increase in State aid to technical/vocational schools under Chapter 78 was unexpectedly not funded, as State fiscal troubles began last spring. Thus, assessments to all seventeen towns in the Minuteman region had to rise unexpectedly. Minuteman's total FY89 assessment to Sudbury is now \$449,347; this is \$79,922 more than that voted at Annual Town Meeting. However, this total assessment is still 2% lower than the FY88 assessment of \$457,070.

BOARD OF SELECTMEN POSITION: The Board supports this Article.

FINANCE COMMITTEE REPORT: Recommend approval and will report further at Town Meeting.

ARTICLE 22A FY89 BUDGET ADJUSTMENT - HIGHWAY, LANDFILL SHELTER

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$12,000, or any other sum, as an addition to the Fiscal Year 1989 Budget voted by the 1988 Annual Town Meeting under Article 5, for Highway Department line item 410-901, Capital Equipment; or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: This adjustment will allow purchase of a prefabricated shelter for the Landfill, required for employees under State regulations, which will replace the unsightly used trailer placed there temporarily thirteen years ago. This is timely now because the winter months are coming. The Board will report at Town Meeting.

ARTICLE 22B FY89 BUDGET ADJUSTMENTS - POLICE & ENGINEERING

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$87,500, or any other sum, as additions to the Fiscal Year 1989 Budget for the Police Department and Engineering Department voted by the 1988 Annual Town Meeting under Article 5, for the following line items:

320-255	Police Contracted Services	\$25,000
320-901	Police Capital Items	\$50,000
502-901	Engineering Capital Items	\$12,500;

or act on anything relative thereto.

Submitted by the Board of Selectmen.

BOARD OF SELECTMEN REPORT: These items, a new computer system for the Police Department and a replacement vehicle for the Engineering Department, are items that the Finance Committee deleted from the proposed FY89 budgets prior to the Annual Town Meeting due to a shortage of funds. They are being presented at the Special Town Meeting for your consideration, highlighted in this fashion because of their need and importance. Further reports on each item will be given at the Special Town Meeting.

FINANCE COMMITTEE REPORT: Recommend disapproval.

ARTICLE 23 SENIOR CENTER ENGINEERING AND ARCHITECTURAL SERVICES

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$97,000, or any other sum, to be expended under the direction of the Permanent Building Committee, for the purpose of obtaining engineering and architectural services, including preparation of plans, specifications, bidding documents and supervision of work, to implement the findings of the Senior Center Task Force regarding remodeling, reconstructing, constructing additional space, or making extraordinary repairs to an existing Town building for use as a Senior Center or the construction of a new Senior Center building; and to determine whether said sum shall be raised by borrowing or otherwise; or act on anything relative thereto.

Submitted by the Council on Aging. (Two-thirds vote is required if bonded.)

COUNCIL ON AGING REPORT: The Council on Aging strongly supports this Article to provide funds for architectural plans and working drawings for a new Drop-In Center. This will cover necessary preparations for erecting a completely new building or remodeling an existing Town building, in accordance with the recommendations of the Senior Center Task Force appointed by the Selectmen.

Voting the funds at this time will save many months, by allowing an Article in the Annual Town Meeting Warrant for construction money, which then would become available July of '89, instead of 1990.

SENIOR CENTER TASK FORCE REPORT: The Senior Center Task Force, having researched and considered an expanded list of possible sites, has narrowed its choice to two of them.

Our preference is the Fairbank Community Center, as the Drop-In Center would be a compatible use with the Pool and other Park and Recreation programs. There is a kitchen, and a large hall for special events. The old classrooms can be divided for different uses. Remodeling is less expensive than a new building, and expansion would be possible in the future, if necessary. Using Fairbank would require finding a different site for Lincoln-Sudbury West.

The second choice is to erect a new building on the Town-owned "Oliver" land on Hudson Rd. That would be more costly, and would tend to isolate the elderly in one section of Town, as it is right beside Musketahquid Village. Its main advantage is that the Center could be built to suit Council on Aging programs.

In either case, approving this Article would be a significant step forward in providing our older citizens with a suitable facility for years to come.

BOARD OF SELECTMEN POSITION: The Board will report at Town Meeting.

ARTICLE 24 TOWN SPACE PLANS

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$480,000, or any other sum, to be expended under the direction of the Permanent Building Committee, for the purpose of obtaining engineering and architectural services, including preparation of plans, specifications and bidding documents, to implement the recommendations of the Board of Selectmen,

for remodeling, reconstructing, constructing additional space, or making extraordinary repairs to existing town buildings, and/or the construction of new town buildings; and to determine whether said sum shall be raised by borrowing or otherwise; or act on anything relative thereto.

Submitted by the Board of Selectmen. (Two-thirds vote is required if bonded.)

BOARD OF SELECTMEN REPORT: It is the intention of this Article to provide planning for new or renovated facilities for Town Departments to include, but not be limited to, those of Executive Secretary, Office of the Selectmen, Town Counsel, Budget Analyst, Town Engineer, Building Inspector, Accountant, Tax Collector, Treasurer, Planning Board, Board of Assessors, Board of Health, Conservation Commission, Town Clerk, Ancient Documents, Finance Committee, Board of Appeals, Personnel, Fire, and Highway. In addition, space will be allotted for a central switchboard, "Public Room", conference rooms, vault, Records Retention Center, employee lounge, storage and maintenance area, and building utilities and general circulation. This article has been prepared in conjunction with and based upon the recommendation of the Long Range Planning Committee (LRPC). A summarized report of the LRPC is given below. We recommend your approval.

LONG RANGE PLANNING COMMITTEE REPORT: During the 1987 Annual Town Meeting it was voted to appropriate \$75,000 to be expended under the direction of the Long Range Planning Committee (LRPC) for the purpose of evaluating and making recommendations toward the use of buildings in Town following an evaluation of space needs and service requirements of all town agencies.

In order to effectively accomplish the study, the LRPC conducted a town-wide demographic study. The next step was to hire a space planning consultant whose preliminary task was to solicit functional and spatial needs from the various town departments, groups and agencies. After reviewing information submitted by questionnaire, doing individual and department adjacency studies, and analyzing the preliminary space requirements, the consultant visited each individual group to discuss its functional requirements, spatial needs, and inter-relationship with other town organizations.

The result of the demographic study noted that the town has grown in physical building development, has had a gradual increase in population, but the demographics of that population were, and are, changing significantly - more young children and more elderly.

The review of the individual space needs determined that many departments have been operating in substandard and inefficient functional and spatial conditions. The town cannot avoid these problems any longer for the reasons listed below.

First, the town approved monies for the architectural and engineering services for the Sudbury Schools. Subsequent to this approval, the Sudbury School Committee chose the Nixon School as the site where space will be provided for its growing elementary school population. The decision will displace the Town Accountant and the Town Treasurer's offices.

Second, the town has not addressed the deficiencies of the central fire station which affects the day-to-day working standards of the Sudbury Fire Department.

Last year the Fire Department agreed to withdraw an engineering and architectural article in favor of the LRPC's study. If this article is defeated the Fire Department will pursue its own expansion article this coming spring. Unsafe, hazardous, and discriminatory conditions exist affecting the health and safety of the Department. These situations cannot continue. In order to bring this Department up to adequate health and safety requirements and meet discriminatory requirements, we recommend expanding the Fire Department within the existing Town Hall and displacing the Town Clerk.

Third, the current locations of the Town's departments are extremely inconvenient for its taxpayers. Equally important, this condition makes it extremely expensive to operate due to the Town's inability to communicate and function as a unit. Many of the services the Town offers are also inaccessible to the handicapped.

Fourth, because of budget constraints and promises of next year, many of our facilities are in an urgent need of repair. Failure to address these needs in the near future will result in excessive reconstruction costs which we do not currently have to face.

Fifth, the legal and administrative costs of a bond issue are high. To bond only a portion of the Town's needs today and another portion within one or two years is a waste of money. Parts of this study have been excluded from this Article and can be funded on a one-time capital expenditure. This includes the renovation and a minor expansion of the Police facility on Route 20 and expansion of the Park and Recreation Featherland facility.

We recommend approval of this Article. For those of you who desire more information, we urge you read our report prepared for the Special Town Meeting prior to voting.

ARTICLE 25 FY89 BUDGET ADJUSTMENT - EDUCATION, SUDBURY SCHOOLS

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$226,000, or any other sum, as an addition to the Sudbury Public School Fiscal Year 1989 budget, Article 5, Section 100 Education, voted by the 1988 Annual Town Meeting; or act on anything relative thereto.

Submitted by the Sudbury School Committee.

SCHOOL COMMITTEE REPORT: At the Annual Town Meeting in April 1988, the School Committee and the Finance Committee were not in agreement on what the School budget needed to be. The difference between the recommendation of the Finance Committee and the request of the School Committee was \$320,000. The School Committee agreed to reduce its budget by \$100,000, and to defer \$220,000 until a Special Town Meeting in the fall of 1988. The need for the additional \$220,000 and the intention to request supplemental funding after Free Cash had been recertified was reported to Town Meeting during the School Committee's budget presentation.

The School Committee is requesting \$226,000. The need for the additional funds comes from three sources:

Budget Needs:

A. **ENROLLMENT INCREASES** exceeded the projections calculated last October 1, 1987. Kindergarten enrollment will be 230. Five years ago 157 children were born in Sudbury. The in-migration of families with young children to Sudbury has resulted in a 46% increase in the number of children in that age group. In past years the in-migration rate averaged 37%. Additionally, more than eighty new students registered for school between June 30, 1988 and September 1, 1988. Increased enrollment brings with it increased costs for teachers and instructional texts and supplies.

B. **MAINTENANCE** costs for asbestos planning and demountable walls. New federal regulations require the completion of an asbestos management plan by a certified engineering firm by early fall 1988. Failure to comply will result in costly fines. The demountable walls were necessary to subdivide rooms at the Noyes Elementary School to provide all the needed instructional spaces for the increased enrollment.

C. **OUT-OF-DISTRICT SPECIAL EDUCATION** tuition and transportation costs exceeded the amounts included in the budget voted at Town Meeting. The increased costs are needed to provide the mandated programs appropriate for these students.

FINANCE COMMITTEE REPORT: In preparation for last spring's Town Meeting, the Finance Committee, in an effort to avoid the necessity of recommending an override of Proposition 2½, asked all Town departments and boards not to seek funding for new services or additional personnel in their respective FY89 budgets. This approach initially met with resistance, but by the time of Town Meeting all concerned had agreed to the Finance Committee's request, and the FY89 budget did not require an override. The Sudbury School Committee is now seeking to supplement its FY89 budget by the transfer of \$226,000 from the Town's FY90 Free Cash.

The Finance Committee views the use of Free Cash prior to the 1989 Town Meeting in any manner other than on a necessity basis as a misuse of Free Cash funds. The removal of monies from Free Cash at Special Town Meeting means that those monies will not be available to offset the expenses of the FY90 budget at next spring's regular Town Meeting.

After several meetings with representatives of the Sudbury Public Schools, the Finance Committee is satisfied that the School Committee's request for additional funding meets the necessity test. It is primarily a consequence of three things: (1) unexpectedly large increases in the FY89 Special Education (SPED) tuition and service/travel accounts; (2) a greater than anticipated cost for a federally mandated asbestos removal inspection; and (3) a larger than anticipated migration of new students into the Sudbury School District. It is not a result of personnel increases or program additions.

As the School Committee has stayed within the budgetary guidelines set by the Finance Committee for FY89; as the Town is required by State and Federal regulations to provide SPED services for those children in the Town who require them; and as the size of the FY89 SPED account increases, the actual cost of the asbestos removal inspection, and the exact number of new students moving into the Sudbury School District could not have been anticipated when the FY89 budget was voted, the Finance Committee recommends approval of this Article.

BOARD OF SELECTMEN POSITION: The Board supports the position of the Finance Committee on Article 25.

ARTICLE 26 BOND OFFERING CIRCULAR - SCHOOL BORROWING

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$12,000, or any other sum, to be expended under the direction of the Town Treasurer for all expenses related to the preparation and issuance of a full disclosure offering circular in connection with the offering of \$750,000 in general obligation bonds for school building engineering and architectural services authorized under Article 4 of the Special Town Meeting held on April 4, 1988; or act on anything relative thereto.

Submitted by the Town Treasurer:

TREASURER'S REPORT: In order to repay the short-term borrowing already done to provide funds for the school building engineering and architectural services described in the Article, it is proposed to offer serial bonds with a maturity of not more than five years. The cost of preparing this offering for public bid is estimated not to exceed \$12,000.

FINANCE COMMITTEE REPORT: Recommend approval and will report further at Town Meeting.

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 27 FY89 BUDGET ADJUSTMENT - DEBT SERVICE

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$20,000, or any other sum, as an addition to line item 200-201, Debt Service Temporary Loan Interest, voted by the 1988 Annual Town Meeting under Article 5 for the Fiscal Year 1989 Budget; or act on anything relative thereto.

Submitted by the Town Treasurer.

TREASURER'S REPORT: This article will be needed only if additional short-term borrowing is approved at the Special Town Meeting. If no further borrowing is required for the current fiscal year, a vote of indefinite postponement will be recommended.

BOARD OF SELECTMEN POSITION: The Board supports this Article.

ARTICLE 28 HIGHWAY DEPARTMENT FENCE

To see if the Town will vote to raise and appropriate, or appropriate from available funds, \$28,000, or any other sum, to be expended under the direction of the Highway Surveyor, for the purchase and installation of an eight-foot high chain link fence around a portion of the Highway Department property located at 275 Old Lancaster Road; or act on anything relative thereto.

Submitted by the Highway Surveyor.

HIGHWAY SURVEYOR REPORT: During the past few years there has been a noticeable increase in vandalism at our Highway facility. Because our building is isolated, it is difficult to prevent these losses. Due to a lack of storage space, equipment has to be stored outside. We have had broken windshields, broken windows in the building, equipment and materials stolen. The funding requested in this Article is a small amount compared to the Town's total invested interest.

BOARD OF SELECTMEN POSITION: The Board will report at Town Meeting.

ARTICLE 29 AMEND BYLAW, ART. IX, I, I - WATER RESOURCE
PROTECTION DISTRICTS (RT. 117)

To see if the Town will vote to amend Section I.I of Article IX of the Town of Sudbury Bylaws, the Zoning Bylaw, by establishing a Water Resource Protection District consisting of the Route 117 Well Number 5 aquifer and its respective aquifer contribution zone (Zone II) and aquifer recharge zone (Zone III), as shown on the following map and by amending the "Water Resource Protection Districts, Town of Sudbury" map accordingly; or act on anything relative thereto.

PLANNING BOARD AND CONSERVATION COMMISSION REPORT: This zoning change, jointly sponsored by the Planning Board and Conservation Commission, identifies the Route 117 Well Number 5 watershed for inclusion in the Town's Water Resource Protection District. The watershed has been broken down into two areas:

1. a 2,640 ft. (one-half mile) radius (compatible with State "Zone II" regulations) from the well where limited, regulated activity may occur by special permit; and
2. the balance of the area in the watershed where certain activities determined to be detrimental to water supply can be monitored and regulated.

The purpose of this Bylaw is to allow for additional protection of our water supply through use regulations in two separate zones spanning the entire watershed of the well area. Surface and groundwater flow in this area have been determined to affect the water quality in the well. By regulating use we can ensure compatibility with the townwide goal of providing quality water to all residents in the Water District.

BOARD OF SELECTMEN POSITION: The Board will report at Town Meeting to allow receipt of input from Planning Board public hearing to be held after printing of Warrant.

ARTICLE 30 AMEND BYLAW, ART. IX, III - WATER RESOURCE PROTECTION DISTRICTS
RESEARCH DISTRICTS

To see if the Town will vote to amend Section III,G,5,c,2) and Section III,G,5,f,2) of Article IX of the Town of Sudbury Bylaws, the Zoning Bylaw, by inserting in the first line thereof after the word industrial ", research"; or act on anything relative thereto.

Submitted by the Planning Board.

(Two-thirds vote required.)

PLANNING BOARD REPORT: This amendment authorizes by special permit those research activities permitted in the underlying district provided there is no adverse impact on the Water Resource Protection District and the interests to be protected thereunder. This technical amendment to the Zoning Bylaw is necessitated by the passage of Article 29.

Printed below is the pertinent section of the Bylaw showing the inserted word:

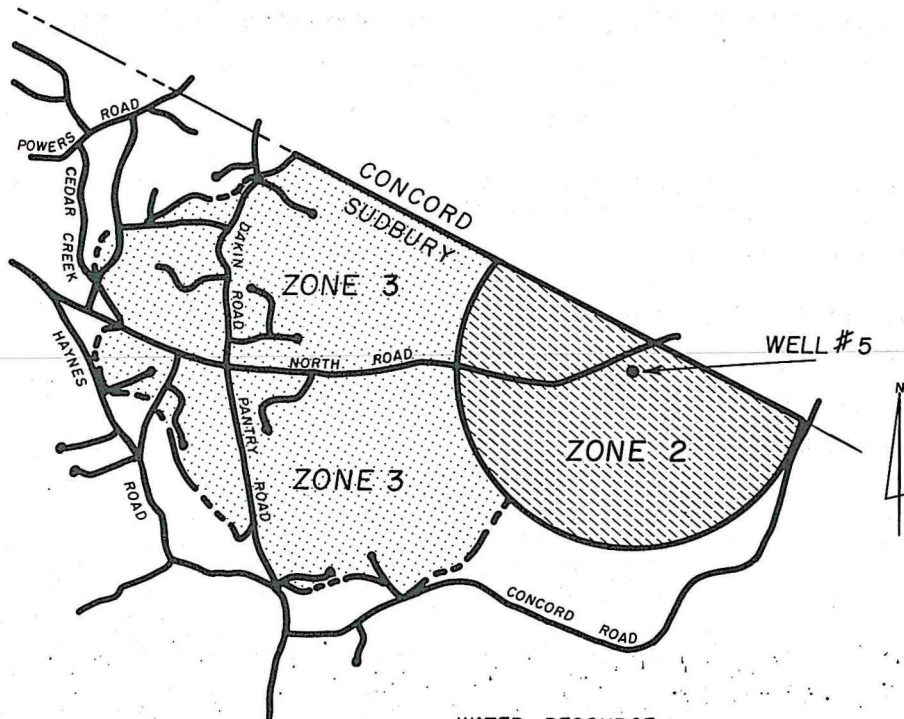
Art. IX, III, G, 5, c, 2):

"c. The following uses are permitted by special permit within Water Resource Protection Districts, Zone II...

- 2) Those business, industrial, research and institutional activities permitted in the underlying district with a site plan review to prevent any adverse impact on the Water Resource Protection District and the interests to be protected thereunder."

(The same wording is used for Zone III.)

- Art. 12 Amend Bylaw, Art. XI Salary Plan Grid
- Art. 13 Amend Bylaw, Art. IV Finance Committee.

It is the opinion of Town counsel that, if the Zoning Bylaw changes set forth in the following articles in the Warrant for the October 3, 1988 Special Town Meeting are properly moved and seconded, reports are given by the Planning Board as required by law, and the motions are adopted by a two-thirds vote in favor of the motions, the proposed changes will become valid amendments to the Sudbury Zoning Bylaw after approval by the Attorney General:

- Art. 6 Amend Bylaw, Art. IX,VI,D Administration - Penalty
- Art. 29 Amend Bylaw, Art. IX,I,I Water Resource Protection Districts (Rt. 117)
- Art. 30 Amend Bylaw, Art. IX,III,G,5 Water Resource Protection Districts (Research Districts).
