Message from the Town Manager

Greetings! I hope you are enjoying the summer thus far. Summer is the time for family vacations, cookouts, and hot, humid days. I hope everyone is looking out for children and seniors as the heat wave continues. The Goodnow Library and the Senior Center are great places to visit anyway, but they can also be great places to cool off on a hot day (or evening for the Library). Keep cool, keep hydrated, and keep safe.

The great news for Sudbury is that there was tremendous turnout for the special election held on June 25th, indicating a lot of interest in the Selectmen's race and the ballot questions. As you may have already heard, Len Simon and Chuck Woodard were elected to the two new seats on the Board of Selectmen, and both the Town Center project and the Police Station design and engineering questions were approved by voters. Staff has already moving forward with work on the two projects, and the new Selectmen have begun digging into the many issues that the Board will be facing in FY14.

I am pleased to announce that I have appointed Lt. Scott Nix, who has been serving as the Interim Police Chief for the past several months, to be Sudbury's next Police Chief. Chief Nix is a Sudbury resident and has been with the Department since 1993. He has been serving as the Department's executive officer (second in command) since 2010. He will be sworn in on July 30, 2013 at 7:15 pm in Lower Town Hall, just before the Board of Selectmen's meeting starts at 7:30 pm. The Public is invited to the ceremony.

From the Selectmen's office

The Selectmen met on July 9th – their first meeting since the election. The first order of business was swearing in the two new Selectmen. Town Clerk Rosemary Harvell administered the oath of office to Len and Chuck, and many Sudbury committee members, residents and Town department heads came to witness the historic occasion as Sudbury moved from a three to a five member Board of Selectmen. Len was joined by his wife Gail, and Chuck by his wife Lisa as they took the oath of office.

The Board then interviewed and approved the appointment of the following residents to Town committees: Carmine Gentile to the Council on



Aging, Fred Bautze to the Historical Commission, and Thomas Friedlander to the Conservation Commission. The Board also re-appointed a number of residents for continuation of service to various boards and committees they have been serving on.

As part of their Consent Calendar, the Board accepted gifts and grants for a number of purposes, accepted a walkway easement, and granted a special permit for a "Bike MS: Minuteman Ride" on July 20. In miscellaneous items, the Board discussed and then reached agreement on which Selectmen will serve as liaison to some Town committees, and where there was a membership role, which Selectmen will serve as a member. They authorized the Town Manager to sign a contract with a consulting firm for property assessment services, and to send a letter to State legislators regarding double poles legislation.

The Board determined that three important issues would be on their next agenda: discussions regarding the Bruce Freeman Rail Trail and the proposed softball field construction project at Lincoln Sudbury High School, and a report from the Route 20 Wastewater committee.

Finally, the Board voted in new officers for FY14. John Drobinski was elected as the new Chairman and Chuck Woodard was elected as the Vice-Chairman.

"The Finance Division is working on the FY14 Budget and Financing Plan document. We hope to publish the document in August. The 200⁺ page book will be made available on the Town's website".

"FY14 Preliminary Property Tax bills were mailed out to all taxpayers at the end of June. First quarter payments are due on or before August 1st."

"During the month of July, the Tax Collector's Office will be mailing out "good news" letters to taxpayers that overpaid in FY13. Taxpayers may request a refund check or balance transfer on their FY14 account."

"Demand bills for real estate and personal property were mailed out at the end of June. Accounts with FY13 tax balances will receive a final notice in August prior to having the delinquencies advertised in the local newspaper".

Department of Public Works

Centerline striping and gutter line striping has been completed on all the Main Roads and Secondary Roads.

Three Methane Gas relief wells were installed at the Transfer Station in association with the installation of the Solar Array.

Work continues on the Old Framingham Road walkway from Framingham Town line to the entrance to Mahoney Farm.

The Town owned parcel at 15 Hudson Road has been graded loamed and seeded.

Drainage System at Canterbury Drive has been repaired.

Ward Road and Mark Lane were resurfaced in July.

The DPW had one Dump truck, one backhoe and one front-end Loader at Truck day at the Goodnow Library and the children loved the experience.

The Traffic lights at the center of Town were out again last week. Bell Traffic Signal Corp. replaced the cable between the manhole at the intersection of Concord Road and Old Sudbury Road to the Master Controller located at the entrance to the Town Clerk's Office at Town Hall. The Traffic Lights hopefully will be in operation until the intersection is reconstructed next spring.

Joseph DeMarco will be the new Light Equipment Operator starting July 22. He will be working in the Drainage Division.

Planning and Community Development

Development activities underway include the commencement of construction at the new Green Company development, Dudley Brook Preserve, located on Tall Pine Drive. This development will include 26 condominium homes for seniors. The Coolidge at Sudbury, located at 189 Boston Post Road, broke ground recently. When completed, this development will include 64 rental apartments for incomequalified seniors. Both of these developments anticipate occupancy beginning in the spring of 2014.

With the approval of the ballot question for funding of the Town Center Intersection project, the Town will finalize the engineering plans and go out to bid sometime in the fall of 2013. Construction is anticipated to begin during spring of 2014, with completion of the project in the summer of 2014.

Walkway construction is due to be completed on Old Framingham Road and Peakham Road in August. Planning for a new walkway on Dudley Road has begun. Any neighborhoods interested in having a walkway constructed should contact the Planning and Community Development office at 978-639-3387.

Sudbury Senior Center

The Sudbury Council on Aging, the advisory body to the Sudbury Senior Center, wishes to share with the community information about the Fairbank Community Center Task Force. COA Chair Jack Ryan sits on the Fairbank Community Center Task Force with representatives from the Park and Recreation Commission, Richard Williamson, several community members and Jim Kelly, Facilities Director. The Task Force has created an RFQ seeking an architectural firm to conduct a Feasibility Study of expansion of the Fairbank Community Center. The study will take place in the fall of 2013. A report will have recommendations for possible expansion of the Community Center and Senior Center in January of 2014. The Council on Aging is seeking feedback from the community about the expansion and the priorities for any change/expansion to the Senior Center. The 5th Congressional District Representative seat represents precincts 1A, 2, 3, 4 and 5 in Sudbury. Because precinct 1 voters are represented by Nicola Tsongas, they will <u>not</u> be included in either the primary or election.

In order to vote in an upcoming election, qualified voters must register 20 days prior to the election. The Town Clerk's office will offer extended hours (9am-8pm) on the last days to register to vote in time for each election as well as Town Meeting.
