# Message from the Town Manager

Greetings! Thanks to everyone who commented how much they enjoyed the September newsletter. With that encouragement, the staff and I will continue to work hard to make sure future newsletters are packed with information that explain how your tax dollars contribute to keeping Sudbury such a wonderful town.

I was able to attend the International City/County Managers Association annual conference in Boston last month. One session began with the speaker asking each of us to think about the following question "what makes for *a sense of place* in a community?" Some folks focused on neighborhoods, some on schools, some on the historical significance of their town, some on the perceived shared outlook on life with fellow residents, such as a community committed to "green" initiatives and much more.

In thinking about Sudbury, I am always struck by two particular aspects – the physical beauty of the Town and the number of kids in Sudbury. In both areas, I think we outshine all our neighboring communities. And if you track our Town budget over time, that is where we put the vast majority of our financial and staff resources – protecting the physical, historical, and environmental assets of the Town and protecting, educating and creating special opportunities for all the children of the Town. We try very hard not to forget any members of our community in our efforts and services, however!

Shown by amount of acceptance per meeting





And second, Peter Anderson, the Town's budget analyst, has created various charts of financial data showing Sudbury compared to ten peer towns. These peer towns are most like Sudbury in nine key areas:


- 1. Distance from Boston
- 2. Density
- 3. Per capita income
- 4. Percent of school age children in overall population
- 5. Percent of tax base from commercial, industrial and personal property class
- 6. Credit rating
- 7. Number of road miles
- 8. Average residential house value
- 9. Amount of tax dollars from overrides per capita

This month, he developed four charts showing how debt and capital expenses in Sudbury in Fiscal Year 2012 (the most recent year for which data is available from the state) compares with our peer towns. In future newsletters he will provide other "snapshots" of financial information.

# From the Selectmen's Office

The Selectmen met three times since the last newsletter – on October 1, October 15, and October 22.

The Board continues to focus on commitments they had made to work on a variety of projects. This includes forming a committee to develop an RFP for Town Counsel services so that the Board can review how best to provide legal services for the Town. It also involves creating committees to generate strategic plans for addressing two pressing long term issues – insuring there is a financing plan in place for the

Town's capital needs and addressing the best way to provide for the unfunded liability for town and school retirees health insurance costs. These three committees have been formed and appointments made to them, and you can check out this information on the Town's webpage.

Along with other Town boards, the Selectmen are engaged in discussions related to the development of the FY15 budget and other financial articles that might be presented at the 2014 Annual Town Meeting. The Board met with the Finance Committee to kick off the budget discussions, and confirmed their commitment to working on the long-term strategic financial issues noted above. The Finance Committee will be hosting and facilitating meetings between leaders of all the cost centers to enhance better information sharing and discussion of key pressure points that affect the budget of all town and schools activities. These meetings will be scheduled by the FinCom and will be posted meetings open to the public. And the Capital Improvement Advisory Committee has begun its work by asking all departments of the Town, SPS and L-S to submit the capital projects to be reviewed by that committee.

Two potential articles for Town Meeting were given attention by the Board. The L-S School Committee invited the Board to hear information about their proposed request for funds to upgrade the technology at the High School facility, and the Board voted to attend a joint meeting of the Recreation Commission and the Conservation Commission to discuss further development of recreation opportunities at the Davis field and on the Parkinson land owned by the Town behind Ti-Sales on Hudson Road.

Another commitment of the Board was to update their rules and regulations related to Alcohol licenses and Chief Scott Nix presented his recommendations for this update. Board members reviewed the draft, and with some final changes, voted to approve the new rules and regulation on October 22. Unfortunately, the Chief also presented the Board with information regarding a license holder in Sudbury who had violated the rules by serving underage customers in a compliance check run by the Sudbury Police Department. The Board voted to send a letter of warning to Soul of India, 103 Boston Post Road for this first infraction.

The Board meets annually with the Board of the Sudbury Access Corporation, and President of SudburyTV Jeff Winston and Director Lynn Puorro used this time to discuss how the coverage of town meetings and other programming has expanded in the past year. One of the highlights is the addition of live streaming of Board of Selectmen meetings, so that even if you are away from Sudbury on meeting nights, you can view the meeting via your computer.

The Board of Selectmen began discussion of the opportunity for the Town to acquire a parcel of land at 233 Concord Road, under a program known as Chapter 61A. Under this program, certain land that is classified as agricultural land may be taxed at a lower rate for as long as the owners keep the land in agricultural use. But if the owners plan to change that use, the Town, through its Board of Selectmen, may choose to exercise a right of first refusal to purchase the land for the Town at the same price the owners have agreed to sell it for (which in this case is \$325,000). The Board heard from a number of residents, mostly who live on Concord Road, urging them to exercise this right of first refusal, which the Board took under advisement. The Board must make their final decision by December 19, 2013. If they choose to exercise this right, then the Board would submit an article to Town Meeting to approve the purchase and appropriate funds for the purchase of the land. As the purchase appears to qualify for Community Preservation Act funding, a vote of the Community Preservation Committee would also be necessary for

this purchase to be presented to Town Meeting in May. Residents are invited to send emails to the Board at <u>Selectmen@sudbury.ma.us</u> if they have an opinion on this purchase question.

Residents continue to volunteer their time to serve their community, and the Board was happy to appoint Patricia Tabloski to the Council on Aging. In other actions, the Board accepted a number of gifts to the Town, approved their meeting schedule for 2014, signed documents allowing the Finance Director/Treasurer to conduct an internal borrowing to provide cash flow for the Police Station design process, met with representatives from OARS, an advocacy and educational group working to protect the Sudbury, Assabet and Concord Rivers, and signed a proclamation making Sudbury a *Purple Heart Community*, honoring the service and sacrifice of service men and women. The Board signed a letter of thanks to Paula Adelson, who is retiring after serving the Board of Health for many years as the Town's Animal Inspector.

#### Sudbury Board of Selectmen's Office Hours

The Board's first Office Hours began on Thursday October 3. Selectmen Chuck Woodard and Len Simon met with two residents who shared their thoughts on various Town projects and the Town's website. The next Office Hours for the Board will be on Thursday November 7, 2013, from 9:00 AM to 10:00 AM at the Sudbury Senior Center, 40 Fairbank Road in the Sudbury Pines Room. Chairman John Drobinski and Selectman Larry O'Brien will be in attendance.

#### **Accounting Department**

October is another busy month for the Accounting Office. Our annual financial audit has started for FY13 and is expected to last for approximately two weeks. All financial records are analyzed and tested by an independent audit firm. The Town's Workers' Compensation audit is also scheduled for the end of the month, and we are currently preparing the required documentation.

The Town's Free Cash figure has been certified by the Department of Revenue. Free Cash results from the closing of the financial records as of June 30<sup>th</sup> and is the amount of funds that are unrestricted and available for appropriation.

#### **Assessors Department**

The Assessing Department has been working diligently to finalize Sudbury's property valuations for the actual Fiscal Year 2014 tax billing cycle. Although Fiscal Year 2014 is not a certification year for Sudbury, it is a requirement of the Department of Revenue that all cities and towns throughout the Commonwealth assess property values annually based on a market value date of January 1st. Sudbury's Fiscal Year 2014 assessments will reflect the property values as of January 1, 2013. Unlike standard appraisals conducted for refinancing or associated with sales, assessed values are set as of a fixed point in time each year. In an effort to determine fair market value as of January 1, 2013, an extensive sales analysis consisting of a review of all Sudbury calendar year 2012 sales was conducted. Additionally, sales questionnaires were sent out to 2012 purchasers, and physical inspections were embarked upon for those sale properties requiring such. As property valuations in Massachusetts are based on a "mass appraisal" system, it is the overall 2012 arm's valid sales market which will dictate the Fiscal Year 2014 assessed values.

In addition to residential property, we are responsible for the valuation of Chapter Land. Chapter Land includes those farm, forest and recreational properties enrolled in special land preservation programs. We also value Commercial, Industrial and Personal Property.

The MWRTA is planning to expand operations into the Blandin Avenue building after it is rehabbed. Plans call for a Van Driver training center, along with additional office space, and a Call Center for dispatch. Future plans include space for a compressed natural gas filling station.

# **Department of Public Works**

In the news from the Department:

1. There were 7 interments since last September, mowing on the shoulders of the streets continues and clearing the cemeteries of leaves

- 2. Parks and Grounds division maintains over 100 acres of Parks, Athletic Fields and School Grounds, and removing leaves from the fields and parks is a priority this time of year.
- 3. Contracts have been sent out to all private snow plow contractors. All contracts are to be returned by Nov. 15<sup>th</sup>. There are over 140 miles of roads and over 40 miles of walkways to be cleared after every snow storm.
- 4. The DPW replaced the entrance walk to Peter Noyes School.
- 5. On Landham Road, the Granite Curb and final wearing Surface of Bituminous Concrete were completed as well as Loam & Seed in the area of the culvert under Landham Road.







- 6. We have over 55 vehicles in the DPW Fleet. For FY15, I have requested 12 vehicles to replace vehicles that are well beyond their useful life and are now experiencing significant repairs. Unfortunately, there are over 16 million dollars in requests for capital items with a budget of \$290,000.
- 7. <u>Engineering</u>: Dan Legere will be leaving at the end of the month, I wish him well on his future endeavors.
- 8. Hudson Road has been widened, curbing installed, drainage installed and the shoulders have been loamed and seeded.
- 9. All work was done in preparation for the town center improvements to begin in the spring of 2014.

#### <u>Library</u>

It's been a busy month at Goodnow. Beginning Monday, October 7, the Children's Room at the Goodnow Library was closed for a makeover that included new paint, carpet, furniture, toys and more to create an exciting new community space. The library staff all pitched in to move over 30,000 books out of the space so the new carpet could be laid, the walls given a bright and warm coat of paint, and the shelving reconfigured to improve access to the collections of picture books, DVDs, and more. During the carpeting phase, the staff worked tirelessly to re-label over 9,000 books. When the renovation work was complete, our work was not yet done! The staff had to put all 30,000 books back into the new layout. What took 5 hours to undo, took 2 days to reassemble, and several staff stayed until nearly midnight to finish. However, thanks to their hard work and perseverance, the room reopened on schedule on Wednesday, Oct. 16. If you haven't seen it yet, make sure to make a trip to the library to see for yourself. Many thanks go to Jim Kelly, the Goodnow Library Foundation and the library staff; it was a team effort, without which we couldn't have accomplished it.

On October 19, the Goodnow Library Foundation held a wine tasting fundraiser to support Phase II of the Children's Room renovation, where attendees could purchase tickets for one of 18 raffle baskets, or sponsor as-yet unfunded items such as a signage, book browsers and even a fish tank. Over 300 people attended the event, which raised approximately \$20,000. We are grateful to both Salt Box Farm and Sudbury Wine and Spirits, who supplied food and drink.

Amy Stimac was hired as Goodnow's Assistant Children's Librarian. Amy started as a part-timer in the spring of 2012, but was asked to assume the interim ACL role in May. Without batting an eye, Amy graciously accepted and took on the enormous burden of helping to plan, promote and execute the most successful summer reading program on record without breaking a sweat. Most recently, during the renovation of our Children's Department, Amy helped to keep everyone focused, hydrated and calm. She is our children's volunteer coordinator (a never-ending, and often thankless task!), enormously talented

children's musician (she's running our "Music Makers" sing-a-long on Mondays for ages 0-5!!), communication guru, and our voice of reason when we start to panic. In short, we would be lost without her. Please join us in congratulating her and thanking her for all that she does and will "officially" do! Looking forward, the Library is wrapping up its sesquicentennial celebrations in December with another Open House. The event will take place on Saturday, December 14, and feature the sealing of the Time Capsule and keynote speaker, Ted Reinstein of Chronicle on Channel 5.

# Sudbury Park and Recreation Department Earns National Accreditation in Parks and Recreation

Mark of distinction recognizes commitment to highest level of service to the community

[Sudbury, MA. October 7, 2013] – Today, Sudbury Park and Recreation joins the ranks of the elite park and recreation agencies and departments across the country by earning accreditation through the Commission for Accreditation of Park and Recreation Agencies (CAPRA) and the National Recreation and Park Association (NRPA). This distinguished accomplishment was awarded during the 2013 NRPA Congress and Exposition in Houston, TX.

CAPRA accreditation is the only national accreditation for park and recreation agencies, and is a measure of an agency's overall quality of operation, management and service to the community. This mark of distinction indicates that an agency has met rigorous standards related to the management and administration of lands, facilities, resources, programs, safety and services. As part of the accreditation process, Sudbury Park and Recreation had to demonstrate compliance with 144 recognized standards and document all policies and procedures. Often the process helps identify efficiencies and heighten areas of accountability, all of which translate into higher quality service and operation to benefit the community.

"I am so proud of all the staff at the Sudbury Park and Recreation Department who worked tirelessly during this three year effort to gain accreditation. As a director I am thrilled to showcase for the community our commitment to providing the best programs around and holding ourselves to the highest standards for our residents." Says Park and Recreation Director Nancy McShea.

The process for accreditation involves self-assessments, a formal application, a site visit by a team of trained visitors that results in a written report, and a hearing with the commission to grant accreditation. Once accredited, the agency must uphold the standards and is reviewed again in five years.

The Commission is comprised of representatives from NRPA, the American Academy for Park and Recreation Administration, the National Association of County Park and Recreation Officials, the International City/County Management Association, the American Association for Physical Activity and Recreation, the Armed Forces Recreation Society and the Council of State Executive Directors.

#### **Public Safety**

#### **Fire Department**

A lot of our efforts over the past few weeks here at the Sudbury Fire Department have been directed toward the launch of our Advanced Life Support Service. Two new special positions have been created to help administer the ALS program. Firefighter/Paramedic Shane Medeiros has been appointed as our Emergency Services Coordinator, and Firefighter/Paramedic Michael Matros has been named the Equipment/Supply/Recertification Coordinator. Both of them have enthusiastically embraced their new roles. Shane has been busy conducting required and optional Paramedic training to make sure all of our personnel are ready to respond in a highly competent manner. In addition to properly preparing our records and ordering necessary supplies, Mike has completely remodeled and restocked our medical supply room from floor to ceiling. The State Ambulance Inspector was quite pleased with all of our progress during his successful inspection to upgrade our ambulance license to the Advanced Life Support level.

With the help of outside professional instructors, Shane arranged training for our ten Paramedics in the areas of Pediatric Advanced Life Support, Electro Cardiogram Competency, and Massachusetts State Protocol Review. In addition, the Paramedics conducted an Advanced Life Support/Basic Life Support Interface Class throughout the entire department to enable our Emergency Medical Technicians to work smoothly alongside our Paramedics at medical incidents.

In the area of fire based instruction, Training Officer Captain Timothy Choate has been continuing his efforts with RIT training. RIT, the acronym for Rapid Intervention Team, concentrates on the methods and techniques for removing a trapped or disabled firefighter from inside a structure during an incident. RIT teams are typically comprised of three of four firefighters, staged near the entrance, who are equipped and ready to intervene in the event of an emergency inside a building. Training took place in three phases: classroom, light gear, and finally with full firefighter gear which includes black out masks, breathing apparatus, and necessary ropes and hand tools.

Captain Choate also integrated our new RIT packs into his classes, which are a portable supply of air that can be connected into a downed firefighter's air supply to effect a rescue. As part of the equipment we will purchase with our FEMA Grant for new self-contained breathing apparatus, we will be receiving three of these extremely valuable RIT packs.

Rapid Intervention Training is a statewide initiative that has received much attention in the wake of studies of recent firefighter fatalities. Captain Choate is working to make this training available on a regional basis, having just conducted RIT training classes for the Concord Fire Department. All of the towns in this area are mutually dependent during incidents, so working together on procedures of this nature is imperative.

I recently attended the annual dinner sponsored by The Hundred Club of Massachusetts on October 9, 2013, at the Boston Park Plaza Hotel. The Hundred Club was founded in 1959 by philanthropist Norman Knight to provide relief for the families of fallen public safety personnel. Attorney General Martha Coakley presented awards to leaders of local, state, and federal public safety agencies who responded to the Boston Marathon terrorist attack of April 15, 2013. The speakers included MIT Police Chief John

DiFava, who gave a heartfelt tribute to slain Officer Sean Collier, and MBTA Police Chief Paul MacMillan, who presented an award to wounded Officer Richard Donohue. It was a moving evening, and provided me with a reminder that we all need to continue to strive for excellence in Public Safety here in the Town of Sudbury.

#### **Police Department**

With the increasing violence in both the school setting and the workplace, I believe we all feel that improving our safety protocols is an important venture. To that end, I have contracted with Response Options Institute to provide a period of instruction relative to the A.L.I.C.E. philosophy (Alert/Lockdown/Inform/Counter/Evacuate). This training is a new evolution of progressive procedures and options that can be applied to school, town or corporate settings; providing an increased chance of survivability in the event a violent circumstance arises.

Lincoln-Sudbury is graciously hosting the training for us on November 19<sup>th</sup> from 8:00 AM to 4:00 PM. The initial part of the curriculum will be held in the lecture hall with the remaining scenarios being conducted in several classrooms. I am in the process of completing a grant application through our insurance underwriter, MIIA, to hopefully cover \$5000 of the total \$6000 cost. Multiple disciplines have been invited to attend, including Lincoln-Sudbury staff, Sudbury Public School staff, Sudbury Town staff (including police and fire personnel), Lincoln Police and School staff and possibly other entities such as Raytheon, if there is availability.

Having provided the school safety training for the last eight years, I feel this is an incredible opportunity to progress in our ability to protect students and staff alike. Unfortunately, we have experienced a homicide in our high school back in 2007 as well as other circumstances that further demonstrate that we are not immune to such tragedies. ALICE – Alert, Lockdown, Inform Counter Evacuate – is a set of proactive strategies that increase chances of survival during a violent intruder event. The ALICE Training Institute provides hands-on training, research based curriculum, and the knowledge of survival strategies for both staff and students.

ALICE is a comprehensive response approach using communication technology, infrastructure design, and the often underused strategies of human action. Content includes - Policy and procedures review, infrastructure and room layout, proactive use of technology, community resource assistance, rapid mass evacuation plans, tactics for countering directed violence, trauma first aid, practical scenario training and lesson preparation.

ALICE is supported by law enforcement and in line with recommendations from the Department of Homeland Security (DHS) and Federal Emergency Management Agency (FEMA).

#### **Planning and Community Development**

On October 23, 2013, the Planning Board opened and continued public hearings regarding the development of the 7 parcels of land in the Willis Hill subdivision. The properties are located on Maynard Road and Widow Rites Lane. The proposals seek approval to construct 7 single family dwellings at these locations. The hearings have been continued to November 13, 2013 beginning at 8:00 pm. On the same night, the Planning Board also adopted Procedures and amendments to the Stormwater Management Bylaw Regulations, Regulations Governing the Subdivision of Land, Rules and Regulations for Senior Residential Communities, Rules and Regulations for Incentive Senior Developments, and Rules and Regulations for Special Permits in the Water Resource Protection Districts. Copies of the final wording of the Procedures are available in the Planning and Community Development Office and will be available shortly on the Town's website.

On November 13, 2013 at 7:30 pm, the Planning Board will also discuss a Stormwater Management Permit application for the construction of a single family dwelling on Newbridge Road.

The Community Preservation Committee (CPC) is soliciting proposals for projects that may qualify for Community Preservation Act funding to be presented at the May 2014 Annual Town Meeting. Proposals can be submitted under any of the four topic areas of: 1) acquisition, creation and preservation of open space; 2) acquisition, preservation, rehabilitation and restoration of historic resources; 3) acquisition, creation, preservation, rehabilitation and restoration of land for recreational use; and 4) acquisition, creation, preservation and support of community housing. The <u>FY15 Project Form</u> can be found on the town's website. Applications are due no later than Friday, November 1, 2013. Public hearings about the proposals will be held during the late fall of 2013.

The Planning and Community Development Department continues their work on affordable housing, both through the Sudbury Housing Trust and the Regional Housing Services Office. Town staff and our consultants have been involved in the resale of affordable units in Sudbury, Lincoln, Concord and Acton, over the last several months, as well as the initial sale of units in the Landham Crossing development in Sudbury. Continued efforts in these areas ensure that our stock of affordable housing is serving the appropriate population and that no units are dropped from our inventory.

The Town's Subsidized Housing Inventory has recently been amended to include the Coolidge at Sudbury units, and according to Dept. of Housing and Community Development statistics, Sudbury currently has 407 affordable units, totaling 6.87% of our 2010 Census year round housing stock.

The Planning and Community Development Department has also been working closely with the DPW Department in finalizing the design plans for the Town Center Intersection Improvement project. We anticipate delivery of the final plans sometime over the winter, with a spring date to bid the project. It is also anticipated that the landscaping phase of the project, funded with 2013 CPA funds, will commence before the end of the calendar year. That phase will include public comment on landscape design of the entire project area, including the new park at 15 Hudson Road.

# **Treasurer/Collector's Office**

We've just marked our 5<sup>th</sup> year of processing passport applications. Since being designated an application agency for U.S. Department of State on June 12, 2008, we have processed 2,515 passport applications to date! This convenience service is provided to the public by certain members of the Finance Department during regular hours of operation. The Town of Sudbury has earned a total of \$62,875 in processing fees. The \$12,000-\$14,000 in fees that we receive annually go into a revolving fund to offset program and departmental expenditures.

**FACTOID**: The 2014 Winter Olympic and Paralympic Games will be held in Sochi, Russia! All US Citizens wishing to travel to Russia are required to have a visa. To obtain a visa in Russia your Passport must be valid for at least 6 months after your departure date from Russia.

\*All passports are *issued* by the U.S. Department of State – A Bureau of Consular Affairs. Issuance of all new passports and renewals is currently running 4-6 weeks. Expedite service for an additional fee of \$65 is running 2-3 weeks. If you need to travel internationally within 2 weeks, you may call the Hotline 24/7 at 1-877-487-2778 to make an appointment at the nearest Federal Passport Agency or Center. You will also need to produce proof of eminent travel at the time of your appointment.

On Tuesday, October 15, voters from precincts 1A, 2, 3, 4, & 5 came to the polls to select two candidates to advance to the December 10 Special State Election to fill the vacancy caused by Edward J. There were 1267 votes cast, representing 12% of the Town's 10,209 registered voters from the precincts that were eligible to vote in the election.
