I look forward to Spring and to seeing you at Town Meeting.



From the Selectmen's Office

January 3

The Board met in Executive Session to discuss issues pertaining to the Wayside Inn property conservation restriction, the <u>Village at Sudbury</u> <u>Station</u> comprehensive permit application as well as potential litigation regarding the <u>Bruce</u> <u>Freeman Rail Trail</u> in Sudbury.

January 10

The Board voted the priority of the Town's five Transportation Improvement Program (TIP) projects and voted to prioritize four large capital projects into their goals. The proposed budget for FY18 was also discussed.

January 12

The Board met in Executive Session in the morning to discuss issues pertaining to the <u>Village at Sudbury Station</u>, release past executive session minutes and discuss issues pertaining to the <u>Eversource transmission line</u> <u>project</u>. Town Forum and Town Meeting logistics were also discussed.

January 24

The Board discussed the status of the <u>Bruce</u> <u>Freeman Rail Trail</u> design with Town Environmental Planner Beth Suedmeyer. They also discussed the need to revitalize the <u>Commission on Disability</u>.

January 26

The Board met Lt. Governor Karyn Polito to sign the <u>Community Compact</u> awarded to Sudbury.

January 30

The Board met in Executive Session to discuss issues pertaining to the <u>Eversource transmission</u> <u>line project</u>.

February 7

The Board discussed possible future use of the <u>Melone Property</u>, and whether there is need for further testing at the site. They also discussed the CSX Rail Corridor with Kelly Boling of The Trust for Public Land Project and its future potential for use as a Rail Trail. FY 18 Budget and Capital Planning was discussed with Susan Berry of the Finance Committee and Strategic Financial Planning Committee. The Board voted a Ballot Question Policy for Elections.

The Board also discussed the <u>Selectmen's</u> <u>Quarterly Newsletter</u>, which is now in its first edition.

Building Department

The Building Department has remained busy this winter with the redevelopment of the old Raytheon property. Permits have been issued for the demolition of buildings 1, 5, test facility and the test tower. The grocery store is moving along with its construction and inspections with hopes of opening in July of this year.

A building permit has been issued for The Bridges Memory Care Assisted Living Facility. They are hoping to start building this spring and be ready for occupancy in about a year. The Avalon project should be in this March for permit applications, if all goes as planned, and the solar projects at 71 Union Ave. and 655 Boston Post Road are nearing completion.

Fire Department

Brimstone Lane Fire

At approximately 2:00 in the afternoon of December 15, 2016, we received a call from a UPS truck driver reporting a fire blowing through the roof at 110 Brimstone Lane. Upon arrival, fire companies found a large home with the wood shingled roof structure fully involved in flames. Assistant Fire Chief John Whalen struck a second and then a third alarm for assistance from neighboring fire departments. Sudbury Firefighters initially laid 2,000 feet of supply hose up the long driveway, set up a relay pumper, and positioned our ladder truck in front of the home for an attack with the ladder pipe.

Surrounding fire departments laid another 3,000 feet of hose to a hydrant on Route 20 and set up three more relay pumpers to increase water flow. Several factors including low water flow from the Brimstone Lane hydrant, a wood shingled roof, a 2,000 foot uphill driveway, blistering cold, windy and slippery conditions, the head start of the fire, and the large size of the structure made firefighting very difficult. the home with a three-inch hose line. Although the home was a total loss, all of the firefighters deserve a great deal of praise for their efforts against these difficult conditions.

Whitetail Lane Fire

We received a call for another house fire at about 7:30 on the evening of Monday, January 16, 2017 at 15 Whitetail Lane. Sudbury Fire companies under the direction of Captain Stephen Glidden arrived to find the attached garage of the home fully involved in flames. The residents of the home had evacuated safely. With a hydrant right in front of the house, Sudbury Fire crews quickly began extinguishment with large volume attack lines. Once again, we were fortunate to receive mutual aid assistance from surrounding towns in bringing this fire under control. All of the Firefighters did a great job knocking this fire down and saving the structure of the home.

It should be noted that the origin of this fire was in the attached garage. Like many homes in Sudbury, this home was built before the 2008 fire code change requiring heat detectors in attached garages. In this case, the alarm system did not sound until the fire had burned into the area of the living space and set off the family room smoke detector. Even though your home may not require a garage heat detector to be wired in connection with the smoke detectors in the living space, this incident proves the value of the additional heat detectors. My own home was not required to have hard-wired garage heat detectors. But after seeing the destruction caused by this fire, and being reminded of the value of garage heat detection, I upgraded the alarm system in my home. Even though your home may have been built before the fire code required garage heat detectors, I highly recommend you consider similar protection. Town Census

The 2017 Annual Town Census has been mailed to all households. Residents should verify or correct all information, sign, and return the census as soon as possible for processing by the Town Clerk's Office. The data from the census is used to compile the Sudbury voter list, Sudbury school planning, and other reports required by Massachusetts General Law, therefore all members of the household, aged three years and older, should be included. If a resident needs a replacement census form, or has any questions, please contact the Town Clerk's Office at 978-639-3351.

A completed census can be returned by mail or hand-delivered to drop-off boxes located outside the Town Clerk's Office (322 Concord Road) and the Flynn Building (278 Old Sudbury Road).

Failure to respond to the Annual Town Census may result in the removal from Sudbury's active voter list and removal from the resident list for any non-registered voters.

Annual Town Election

Candidates who have met the requirement of obtaining fifty certified signatures on their nominations papers are eligible to appear on the ballot at the Annual Town Election, scheduled for Monday, March 27. Polls open on Election Day at 7:00 a.m. and close at 8:00 p.m. Precincts 1, 1A, 2 & 5 vote at the Fairbank Community Center, 40 Fairbank Road. Precincts 3 & 4 vote at the Town Hall, 322 Concord Road.

Voter Registration Deadline

The last day for a qualified resident to register to vote or make changes to an existing voter

registration for the Annual Town Election is Tuesday, March 7, 2017. The Town Clerk's Office will hold an extended voter registration session until 8:00 p.m. on March 7. For more information on <u>registering to vote</u>, please see our website.

Dog Licensing

All dogs aged six months or older must be licensed each year. Applications for <u>dog</u> <u>licensing</u> can be found inside the census packet, at the Town Clerk's Office, or on our website. The dog licensing period extends from January 1 through March 31, 2017. Beginning April 1, a late penalty fee of \$25 will be assessed for each unlicensed dog, in addition to the regular licensing fee (Town Bylaw Article V, Section 3A.) The Town Clerk's Office will remain open until 8:00 p.m. on March 31 to assist residents in licensing their dogs.

Bruce Freeman Rail Trail Design Project: Opportunities to Receive the Latest Information and Comment

The 4.4-mile Rail Trail project is approaching an important milestone—the 25% design stage submission to the MassDOT, and there are several upcoming opportunities to become informed about preliminary design plans and submit comments.

<u>Abutter's Meeting</u>: The Bruce Freeman Rail Trail (BFRT) Design Task Force will hold a meeting specifically to take comments from proposed rail trail and alternate (roadway) route abutters on **Thursday, March 2 at 7:30 PM at Lower Town Hall**.

Public Information Meeting: A BFRT Public Information Meeting will be held on **Thursday, March 9**, **2017 at 7:00 PM at Lower Town Hall**. Updates on the preliminary design of the BFRT Project will be presented and comments will be received.

<u>Written Comments</u>: The BFRT Design Task Force will accept written comments **until March 14, 2017** for consideration in the 25% Design Recommendations, which will be submitted to the Board of Selectmen. Please send written comments to <u>pcd@sudbury.ma.us</u> and include your name and address for the public record.
