#### **Construction Projects**

The storage facility at 560
Boston Post Road is underway
and should keep us busy for the
next 12 months or so.


Coolidge Phase 2, the senior apartments at 187 Boston Post Road, is moving along quickly and is expected to done sometime this fall.

Cold Brook Crossing is in its final planning stages and should be applying for permits this summer.

#### **Swimming Pools**

Swimming pool permits have been very popular this summer. Homeowners need to be aware of the Building Code requirements for barriers around their pool to help prevent accidental drowning. Any pool or spa with a water depth of 24" or greater requires a Building Permit and must meet code requirements. The Building Department website has a link to the swimming pool and spa code requirements.

## Conservation Department

For the Conservation Commission and Department, the summer months have been as active as ever before, if not more! Social isolation has resulted in Sudbury residents improving their personal recreational space, which have kept the office busy with numerous tree removal requests, landscaping, and pool permits being sought. The Commission continues to meet on the Bruce Freeman Rail Trail initiative as well as review a joint application from Eversource and the Department of Conservation and Recreation (DCR) to construct and operate a high voltage transmission line on the MBTA corridor, where DCR plans to create the Mass Central Rail Trail.

#### **Conservation Lands**

Our Conservation Lands have seen a great deal of traffic this spring and summer. We encourage all those interested in taking advantage of these lands to visit the Conservation Lands web page and look under Conservation Lands that have maps, and information about the sites, with video tours available to view.


The Commission also recommends adherence to our COVID Etiquette, including social distancing and keeping dogs on leash, to continue to keep Sudbury safe.

#### **Statewide Drought**

The Secretary of Energy and Environmental Affairs, Kathleen Theoharides, declared a Level 2-Significant Drought in the Western, Connecticut River Valley, Central and Northeast Regions.

The state asks residents to be mindful of the amount of water they are using, and to be proactive in reducing or eliminating outdoor water use, reduce indoor water use, and address plumbing leaks as soon as possible. Limiting nonessential outdoor watering is one of the most effective ways to minimize the impacts of drought on the water supply and the environment, and ensure there is enough water to meet essential needs, such as drinking water and fire protection, and so habitats have enough water to recover. Also please be aware of Sudbury Water District use restrictions.

Please be mindful of your water use, especially during this COVID crisis, and have a safe, healthy, and happy summer!

#### Northern Section of Concord Road to Close for Culvert Repairs

Repairs to the Concord Road culvert in North Sudbury will commence on July 9. A roadway closure and detour will be necessary through early September due to the narrow right-of-way with limited space for staging and construction activities. Message boards are in place to notify residents of the impending construction. Local traffic on both sides of Concord Road will be allowed during the closure but travel through the construction zone will be prohibited.

Subsequent to a hit-and-run motor vehicle accident which dislodged the guardrail and headwall, the headwall collapsed into Cold Brook partially occluding the upstream portion of the culvert. The Public Works Department team removed the occlusion and secured the site by installing concrete barriers and reflective construction barrels.

This culvert crossing is completely submerged and not visible under the water's surface. In order to properly assess the condition of the culvert under the roadway a team of commercial underwater divers were contracted to investigate the culvert barrel. It was determined that the culvert is in good condition but it is partially clogged with debris. Further structural assessment revealed the footings at both ends of the culvert need replacing. For compliance with MassDOT crash barrier standards the stone parapet wall on the culvert's southern side also needs to be replaced.

The Town's engineer, BETA Group Inc., developed a low-cost solution involving new guardrail bolted to cast-in-place concrete moment slabs with underlying footings surrounding the existing culvert.

Debris blocking the culvert's cross sectional area will also be removed during construction. The most challenging portion of this project will be successful dewatering of the work area in order to properly construct the footings.

The project received six competitive bids with the lowest being accepted for a cost of \$242,050. R. Bates and Sons, Inc. of Sterling is the general contractor and BETA Group, Inc. of Norwood will be assisting with construction administration and inspection.

#### **Especially for Teens**







## Tick-borne disease by the numbers.

#### Increase in Tick Disease Reported

Prevention is the Key

Over the past two weeks, Sudbury

Health Department has seen an increase in tick-borne illness including Anaplasmosis, Lyme and Babesiosis. The majority of cases of tick-borne disease occur in June through August. Although not every tick is carrying a disease, it is important to take steps to avoid all tick bites. The Sudbury Health Department wants to remind all Sudbury residents of some important precautions to help guard against tick-borne disease.

This map shows the rate, per 10,000 total population, of ED visits by patients who had a visit related to a tick exposure, by Massachusetts county of residence, 2020 to date. Although there are differences in the rate of patient visits, this shows that people are exposed to ticks throughout all of Massachusetts and should take recommended steps to reduce the chance of being bitten.

- Be aware of wooded areas with high grasses or leaf piling (where ticks hide)
- Walk in the center of trails
- Wear tick repellant containing DEET of at least 30% or clothes treated with permethrin
- When returning home after having been outdoors, bathe or shower as soon as possible to wash off or find ticks crawling on you
- Do a tick check after spending time outdoors (don't forget your pets)
- Call your Health Care Provider immediately after a tick bite to discuss exposure and treatment.
- Test your Tick at UMASS



## SUDBURY EMERGENCY RENTAL ASSISTANCE PROGRAM (ERAP)

#### APPLICATIONS ARE CURRENTLY BEING ACCEPTED

WHAT IS ERAP? See Guidelines and Application FAQ for more detail.

ERAP provides temporary monthly rental assistance in the form of a grant to eligible households who have a loss of income due to the COVID-19 pandemic. ERAP will pay between \$350 - \$800/mo. in rental assistance, depending on unit size for four months. Payments are made directly to the landlord. Grant renewals may be possible depending on need and available funding. ERAP is funded is through the Sudbury Housing Trust.

#### WHO IS ELIGIBLE?

- <u>Current residents of Sudbury</u> not currently receiving rental assistance or in a unit where rent is based on income. Also, households that own other real estate do not qualify.
- Households who have had their income reduced due to circumstances related to the COVID-19
- Households who spend over 30% of their income on rent
- Households whose current monthly rent is below the following:

1 bedroom - \$1,925 2 bedroom - \$2,311 3 bedroom - \$2,880 4 bedroom - \$3,131

Households whose income is below the following limits:

The design of the Bruce Freeman Rail Trail (BFRT) in Sudbury (Section 2D, Project # 608164) has reached an important milestone with MassDOT approval of the preliminary, 25% design and scheduling of the Design Public Hearing.

MassDOT's virtual Design Public Hearing for the BFRT in Sudbury was presented as a webinar video online on July 16th.

Public comments to be captured as part of the Design Public Hearing proceedings are due to MassDOT by July 30. The video is now available and additional comments may be submitted on an ongoing basis following compilation of the Public Hearing proceedings.

#### **About Bruce Freeman Rail Trail** 25% Design

The Town of Sudbury is the project proponent, coordinating and funding the project design, and has advanced the project to this preliminary design stage in coordination with MassDOT. The construction is estimated at \$13.4 million dollars and will be funded through the Boston Metropolitan Planning Organization **Transportation Improvement** Program (TIP) in federal fiscal year 2022. TIP projects are subject to a specific set of guidelines, including the 25% Design Public Hearing. Following the Design Public Hearing, the Town will continue to advance the project design in close coordination with and meeting the requirements of MassDOT.
