

# Reminder: Propose a Study Idea for the FFY 2024 Unified Planning Work Program (UPWP) by February 15

## TAKE THE SURVEY

The Boston Region Metropolitan Planning Organization (MPO) is collecting ideas for new transportation studies to be included in the Federal Fiscal Year (FFY) 2024 [UPWP](#).

Each year, the UPWP supports efforts to gather data about the region's transportation system, identify the needs of transportation system users, and develop a range of transportation project concepts. These efforts provide insight and recommendations to the MPO's municipal and regional partners, and help shape the region's transportation future. Our goal is to create communities that are safe, accessible, walkable, bikeable, and resilient, and anticipate trends shaping the transportation industry.

Study submissions should include:

- Context of the underlying problem
- Potential solutions to explore
- Anticipated outcomes
