Budget/Consultant Working Group Report for 8/26/21 DEI Commission Meeting

The Budget/Consultant Working Group members are: Nancy Kimble, Nuha Muntasser, Stephanie Oliver and Susan Tripi. The group's initial goal was to identify the types of training or consultant services that might be utilized by the Commission and to explore costs and potential sources of funding. The group started by reviewing the list of DEI training and consultant resources sent by Town Manager Henry Hayes, as well as other resources shared by Commission members.

The group quickly identified the Sudbury Foundation DEI mini-grant program as a potential source of funding, and had to move quickly because grant applications were due 8/20/21. Because grant decisions would be made in October, the group decided to focus its grant request on support for a consultant to assist with a town survey and/or storytelling/lived experiences project, rather than on training for the commission. The rationale was that training for commission members should happen prior to October, and also that there are quality free training resources already available online from organizations such as the National League of Cities. The group decided that it would be beneficial for all Commission members to view two webinars presented by the National League for Cities REAL 101: Normalizing Racial Equity in Local Government, and REAL 202: Advancing Racial Equity in Local Government.

In an effort to identify the potential costs for a consultant, members of the working group reached out to DEI commissions/groups in other towns that had done similar work. Dr. Anna Giraldo-Kerr, who led the Lived Experiences Project for the Town of Needham, was identified as a potential consultant and Susan Tripi had an initial conversation with Dr, Giraldo-Kerr.

The working group decided to apply for the Sudbury Foundation grant in the amount of \$5,000 (the maximum amount), which would be used to hire a professional consultant to assist in the development of a town-wide survey and Lived Experiences Story campaign, and to provide training for the Commission members to ensure a sensitive and successful administration of the project. The grant application was sent to Henry Hayes for him to submit to the Sudbury Foundation on the Commission's behalf for the 8/20/21 deadline.
